CONDITIONS OF MEMBERSHIP

1. A Membership is not transferable by the Member for any reason whatsoever, and no subsequent modification of this agreement may be made except in writing and agreed to by all parties. All applications for membership are subject to approval by the club which shall have sole discretion to approve or reject same for any reason whatsoever.
2. All fees are due and payable in advance. If any Member fails to make any payments when due, the Club may elect to terminate the membership. A terminated Member wishing to rejoin the Club must pay the initiation fee in effect at that time. All fees paid are nonrefundable.
3. Membership conditions require a one year commitment from the date this agreement is signed. Termination prior to one year allows Salem Golf Club to pursue collection of remaining dues and/or prevailing initiation fees at the time a member wishes to re-join.
4. If any legal action is necessary to enforce the terms of this Agreement, the prevailing party shall be entitled to reasonable attorney's fees in both the trial and appellate courts.
5. It is intended that this Agreement comply with all applicable laws and regulations, to the extent that any provision be ineffective and that the rest of the Agreement remain in full force and effect.
6. The Club reserves the right to increase fees at any time upon the giving of thirty days notice to the members.
7. Member on behalf of himself, his heirs, executors, administrators and assigns, hereby acknowledges that use of the Club's facilities and services may be dangerous and hazardous and may involve dangerous and hazardous conditions both obvious and latent and Member hereby assumes all risk to his person and property arising out of Members' use hereof. Club shall not be liable for any injury, loss, or damage to person and/or property, and Member, on behalf of himself, his heirs, executives, administrators and assigns does hereby expressly forever release and discharge the Salem Golf Club, its successors and assigns, its operators and agents, from all such claims, demands, injuries, damages, actions and causes of action. Member further agrees to indemnify Club for all legal expenses incurred in defending against any claim or suit brought against Club to recover for damages sustained through accident or injury caused by Member.
8. Membership is a license to use the Club's facilities only and is not an interest in the income or assets of Salem Golf Club. Termination of the Club shall terminate each membership.
9. Hours of operation are subject to reasonable adjustments at the discretion of the Club management including but not limited to changes for holidays, special occasions and for the performance of maintenance to the Club's facilities. Whenever possible, notice of such changes will be posted on the Club's premises.
10. The Club shall be entitled to terminate a membership by written notice upon any of the following occurrences: When an account becomes 45 days past due; for violations of Club policies and procedures; abuse of or destruction to the Club's property or their premises; abuse of other members or Club employees; or theft of any property belonging to the Club or a member or visitor.
11. Upon reaching their 22nd birthday, children are no longer eligible members under a family membership. They may, within 30 days, acquire their own single membership without paying an initiation fee.
12. THIRTY DAYS WRITTEN NOTICE IS REQUIRED TO CANCEL OR TERMINATE A MEMBERSHIP. Such termination of membership DOES NOT release individual from liability for any unpaid dues, charges, or fees through the month of termination. A membership termination is not retroactive and terminating members are not entitled to a refund of any part of the Membership fees or dues. Membership cards must be turned in upon termination of a Membership.
